I also understand that I am booking an adventure holiday and standards such as accommodations, transportation, medical service, and other factors may not be maintained or operated to standards commonly found in the United States, or on a conventional "resort style" vacation.

RELEASE OF LIABILITY AND ASSUMPTION OF ALL RISKS

Go Now Adventures LLC gives notice that the services provided in connection with your trip itinerary, including for example, transportation companies, hotel or other lodging facilities, restaurants, adventure trip companies, equipment suppliers, and other goods or services used, are purchased from various local independent travel suppliers. Go Now Adventures LLC does not own or operate these entities. By utilizing the travel services of these independent suppliers, Go Now Adventures LLC, its employees, shareholders, subsidiaries, affiliates, officers, directors, successors, agents, and assigns (collectively Go Now Adventures LLC) shall not be liable for any negligent or willful act or failure to act of any such person, or of any other third party.

I understand the responsibility of Go Now Adventures LLC is strictly limited. As a US-based adventure travel company, Go Now Adventures LLC organizes, promotes, and sells tour programs consisting of, but not limited to, the travel services mentioned above, which Go Now Adventures LLC purchases or reserves from various suppliers in my behalf. I am aware, and clearly understand, that the suppliers providing travel services for tour programs sold by Go Now Adventures LLC are independent contractors and are not agents or employees of Go Now Adventures LLC, nor does Go Now Adventures LLC act as an agent for any supplier of travel services.

I acknowledge that I have voluntarily applied to participate in the trip designated on this application (or a trip to which I may subsequently transfer). I am voluntarily participating in this trip with the knowledge of the numerous risks and dangers involved including but not limited to: physical exertion for which I am not prepared; forces of nature; transportation failures whether by plane, auto, truck, boat, kayak, bicycle, horseback or other animal, by foot, or by any other conveyance; consumption of alcoholic beverages; risks associated with food or impure water; civil unrest; terrorism; criminal activity; dangers associated with wild or other animals, breakdown or faulty maintenance of equipment; insufficient instruction or assistance; high altitude, accident or illness without access to means of rapid evacuation or availability of medical supplies or services; the adequacy of medical attention once provided; stolen, lost, or misplaced luggage or property or shipped purchases or other goods home from abroad. I understand that Go Now Adventures LLC will have no liability regarding the adequacy of any evacuation plan, medical risks incurred by travel and activity beyond the accepted safety of life at home or work and that these inherent risks contribute to such enjoyment. **I HEREBY AGREE TO BE RESPONSIBLE FOR MY OWN WELFARE AND ACCEPT ANY AND ALL RISKS OF DELAY, UNANTICIPATED EVENTS, INCONVENIENCE, ILLNESS, INJURY, LOSS, EMOTIONAL TRAUMA OR DEATH.** I acknowledge that the cost of all Go Now Adventures LLC trips are based upon trip participants executing this Release of Liability, Assumption of All Risks, and Arbitration Agreement. Therefore, as lawful consideration for being permitted to participate on such trip(s), **I HEREBY RELEASE AND DISCHARGE FOREVER Go Now Adventures LLC FROM AND AGAINST ANY AND ALL LIABILITY ARISING FROM MY PARTICIPATION IN THE TRIP.**

I agree that this release shall be legally binding upon me personally, all members of my family and all minors traveling with me, my and their heirs, successors, assigns, and legal representatives, it being my intention fully to assume all the risks associated with this trip and to release Go Now Adventures LLC from any and all liabilities to the maximum extent permitted by law.

PHOTOGRAPHY RELEASE

You grant Go Now Adventures LLC, as well as those acting on its behalf, a worldwide, royalty-free, perpetual license to use, re-use, distribute, display, create derivative works of, and reproduce any images, photos, or videos that you provide to us (whether directly or through a photo sharing service) (collectively, "Your Images") in any medium, including but not limited to print, electronic media, or Internet, free of charge and without your right to inspection, for any purpose, including to promote and publicize our travel products and services worldwide. You also acknowledge and agree that we or other parties, including but not limited to our third party suppliers and other participants, may during your trip take or create images, photos, sound recordings and videos in any format that contain or feature you or any minor under 18 years of age traveling with you (collectively, "Trip Images of You"). These images may contain your or the minor's name, likeness, identity, photographic image, videographic image or oral or recorded statements. You agree that Go Now Adventures LLC and its suppliers may use Your Images and the Trip Images of You for any purpose, including to promote and publicize our travel products and services, and grant us a perpetual, royalty-free, worldwide, irrevocable license to use such images without your prior inspection. Should you have specific photography concerns, please bring them to our attention prior to your trip.

BINDING ARBITRATION

In the unlikely event of any dispute concerning, relating, or referring to this contract, or any literature concerning my trip, or the trip itself, I agree to the following conditions: 1) the dispute shall be resolved exclusively by binding arbitration in Bensenville, Illinois according to the then existing rules of the American Arbitration Association; 2) the maximum amount of recovery to which I will be entitled from Go Now Adventures LLC under any and all circumstances shall not exceed the amount of its fee for professional services, less actual expenses incurred in arranging my travel. Such proceedings will be governed by substantive Illinois law. Should any part of this contract be found invalid or not enforceable by a court of law, then the remaining portion shall continue to be valid and in force.

KNOWING AND VOUNTARY EXECUTION

My signature below certifies that I have carefully read and fully understand the contents of this agreement including the Terms and Conditions, especially those regarding cancellation and refund policies, limitation of liability, and responsibility borne by trip participants.
